## School Attendance Matters

Dear Parent/Carer,


Here at Banks Road Infant and Nursery School we strive for the highest standards of attendance and achievement. If a child is registered at school, his or her parents have the primary legal responsibility for ensuring that their child attends regularly. The law states that children of compulsory school age must be educated. Where a parent/carer chooses for that education to be carried out in a school, then attendance at that school is a statutory requirement. Prolonged and irregular absence can disadvantage pupils.

Children should be at school, on time, fully equipped and prepared for learning every day the school is open unless the reason for absence is unavoidable. In allowing absence from school without a good reason, the parent/carer commits an offence and legal action may follow.

I would like to take this opportunity to remind parents about the importance of good attendance and punctuality. Excellent attendance results in excellent attainment. We have a duty and responsibility to encourage children into the habit of attending regularly in order to achieve their full potential. Monitoring attendance occurs on a regular basis and if the school becomes concerned about attendance due to a high number of absences due to illness, we may seek to obtain a medical letter explaining the reason for the absences.

As such, we would very much appreciate your co-operation by following the guidelines below.

## Reporting absence

It is important that you contact the school before 9:30am on the morning of any absence. Failure to do so will result in a phone call home from the school office, or a home visit if we are unable to contact you, to ascertain the reason for the absence.

## Medical/Dental Appointments

We encourage parents to make appointments out of school hours.

## Term Time Holidays

Parents should not take pupils on holidays in term time. Schools can only agree to absence for a family holiday if they believe there are special circumstances which warrant it. The school will then return the holiday form stating whether they authorise the holiday or not. If not, the school will state the reason and also point out that if the family choose to go ahead and book the holiday then they will be considered for a Fixed Penalty Notice of $£ 60$ (if paid within 28 days) or increasing to $£ 120$ (if paid within 29 and 42 days).

## Unauthorised absence

If the school does not receive a justifiable reason for absence then this will be classed as "unauthorised absence" which could lead to a Fixed Penalty Notice and a fine of $£ 60$ (if paid within 28 days) or increasing to $£ 120$ (if paid within 29 and 42 days).

## Authorised absence

Only the Head teacher can authorise any absence in line with Government guidelines. Any request for authorised absence must be made in writing to the Head teacher (prior to agreeing to any arrangements).

## What you can do to help

You can do a great deal to support the regular and punctual attendance of your child including:-

- Ensuring that your child arrives at school on time each day
- Ensuring that your child only misses school for reasons which are unavoidable or justified, such as illness or days of religious observance.

The most important thing that a parent/carer can do is to make sure that their child goes to school regularly and arrives on time. Starting these habits at an early age while the child is in primary school, and better still before this, will make life much easier later on. Giving children positive messages about school attendance during their formative years is good parenting, and it contributes to better management of the adolescent years. Failing to attend school regularly can have a major impact on a child's education, their future and their life chances. There is strong evidence to show that absence has a serious impact on a child's performance in tests and examinations and means that they will fail to meet their full potential.

It is surprising how quickly absences can add up. $90 \%$ may sound good but the grid below highlights the number of days missed throughout the year is 19 - nearly 4 weeks of lost education. If your child's attendance is below $94 \%$ this is seen as poor attendance and you may be asked to discuss the reasons with the school and a medical letter sought.

As we say at Banks Road: "Every minute, of every hour, of every day counts".

| Percentage <br> Attendance | Time missed in days over 1 year | Time missed in days over 3 years |

| 90\% - 95\% | 10-19 days missed | 30-57 days missed |
| 85\% - 90\% | 24-30 days missed | 72 - 90 days missed: The equivalent of more than 1 term |
| 80\% - 85\% | $32-40$ days missed: More than half a term | $96-120$ days: The equivalent of two terms |
| Below 80\% | More than one day every week is missed which is more than 40 days a year | One year missed out of three or children miss two full years of their primary education |
